# 2.1 Bachelor of Science Nursing (BSN) COTR Practicum Students in Schools

Candice Spears from the College of the Rockies introduced herself to the Board and presented the Board with the benefits of having (BSN) Practicum students in schools.

- Tuesdays and Wednesdays are the (BSN) students' practical hours.
- A third year nursing student is in an elementary school and is benefiting the students. The nursing student went into classrooms to discuss hand washing, body image, ways to control anxiety, diabetes, allergies, just to name a few.
- Candice explained that her (BSN) students could also bring benefits to the middle schools and high schools.
- The College of the Rockies has a placement programmer who contacts the school principals by email in March each year to place students for September.

Candice provided answers to the Board questions:

- Students have been placed in schools in the Elk Valley along with Cranbrook.
- Criminal record checks are up to date on all (BSN) students.
- Very clear regarding confidentiality with no names being shared.
- There are currently 32 seats for (BSN) students and will be going up to 40 seats in September.
- All (BSN) students are fully vaccinated for COVID-19.

Vice-chair Trustee Turner thanked Candice for her presentation and advised that Director Casault would be the contact person in School District 5. Sandy Gronlund will forward Director Casault's contact information to Candice.
