#### 2. PRESENTATIONS

#### 2.1 COTR Research - Place Based Learning - COTR Practicum Students

Tina Sandhu and Kyla Patton, 4th year nursing students from the College of the Rockies presented their research and their personal observations/recommendations from a nursing perspective on the benefits and challenges of conscious place-based education.

Observations:

- location of school and funding either worked well or it did not
- the higher the grade level the less engagement
- safety was another barrier; teachers were not feeling comfortable taking students outside without first aid training
- place-based education has the environmental piece which connects with health and the environment
- connecting mental health with the environment is very important; helps to build fundamentals in children at a young age

Recommendations:

- effective planning key
- place-based workshops for teachers
- help build community in schools; bouncing ideas off each other/collaborating with other teachers
- first aid courses for teachers
- flexible timetabling to allow longer lunch hours to access community
- opportunities for place-based learning in urban community as well
- place-based learning very broad; important to define barriers

#### 2.2 Performing Arts BC Festival - Gail Brown and Corinna Robinson

Corinna Robinson, representative from the East Kootenay Performing Arts Festival presented information on the BC Performing Arts Provincial Festival coming to Cranbrook June 2-6, 2020.

Highlights included:

- 2400 visitors over 4 days; 650 plus children and youth performers across the region including our students
- encouraging SD5 students/staff to attend concerts/events
- opportunity to showcase the East Kootenays promoting return visitors and perhaps relocations
- will increase the awareness of the Arts in our region
- various venues around the region have already committed to holding events/concerts/practises
- budget of \$65,000 looking for partnership with SD5, support, in-kind donations, sponsorships, use of SD5 facilities, Key City Theatre days
- Local community keeps 25% of the proceeds

Director Tichauer met with Gail Brown and has secured pianos for practises at two schools (SES and AWES). Key City Theatre days will be donated but

can not be determined until closer to year end. The use of SD5's facilities for practises will also be donated.

A discussion took place as to other venues in the Elk Valley which could be utilized. The provincial board is encouraging visitors to stay around and explore the Cranbrook area. A letter of support will be drafted from the Superintendent's office for the Provincial Festival. Trustee Johns will work with Gail Brown on the walkable map project.

#### 2.3 September 20 Pro-D Survey Results - Jason Tichauer

Director Tichauer gave a brief summary of the district day survey. Highlights included:

- 97 responses
- great comments on the physical space at both venues and how things were set up
- few negative comments about sitting all day vs. interactive or moving around
- some teachers thought this day was going to provide more tools/resources/teaching strategies for reconciliation
- this day was not supposed to be a workshop type of a day but more overarching; was not meant to be researched based

A discussion took place on how to improve this day. Director Tichauer met with ?aq'am last week and they discussed co-planning the next Indigenous focussed professional development day with us. This is great news. District Management will be looking at which specific day next year will be Indigenous focussed and will discuss who should be attending this day. We are now ready to move forward with the planning. Buy-in from all staff, management and the community is evident due to the great work we are doing in Aboriginal education.

## PROVISION OF MENSTRUAL PRODUCTS TO STUDENTS

#### SECTION

The Board of Education of School District 5 (Southeast Kootenay) is committed to providing menstrual products to students who may require them.

The Board will:

- ensure menstrual products are made available to students of all gender identities or expressions in a manner that protects student privacy;
- provide for barrier free, easily accessible menstrual products at no cost to students;
- provide menstrual products in school washrooms; and,

Mr. Rice reported that we are waiting for the MBSS building assessment report from Stantec. He will update the Board at the December 10, 2019 Board meeting.

- Mr. Reimer will provide information on the WorksafeBC reports after each DOHSAC meeting and bring forward to each Fin/Ops/Personnel Committee meeting.
- Mr. Tichauer will provide a high level statistics of threat/violence reporting on a monthly basis at the Finance/Operations/Personnel Committee meetings.





### **Professional Development**

On Friday. December 6, there was a professional development opportunity for Education Assistants and Youth Care Workers in Fernie and in Cranbrook. There was a keynote speaker at each location and break out sessions in the afternoon.

Kori Vernier, a local professional forester joined the class outside and shared information about careers in the forest industry and other forestry related topics. Students asked questions and discussed their observations while being out in the environment.

# ENGAGING ALL LEARNERS

In November, students in Madame Wolchuk's grade 8 French class at Elkford Secondary became "French travel agents". Madame Wolchuk created a project where students collaborated and chose a French speaking country and researched a popular tourist spot. Using tools from Google Maps/Earth, students wrote out the directions in French to get from the airport to the desired location. They wrote a simple script and then were filmed in front of green screen with the chosen location as the background image. Students will continue to work on this project with the creation of a tourist brochure. As a culmination to the project, each student will then get to "visit" the location using the Wander app on the Oculus Quest headset. By the end of the project, students will have "travelled" to Paris, Nice, Montreal, Quebec City, Tahiti, and even Madagascar!

Students in Mrs. King's Environmental Science 11 at Elkford Secondary have been studying various ecosystems. As part of a larger project, they used the Oculus Quest VR to "experience" their chosen place. One group studying Chernobyl were able to "tour" the site safely. The group stated that after "touring" Chernobyl, it made them more curious about what happened there and they would like to visit it in person. Other groups toured a rainforest, a desert and other diverse ecosystems.



### Physical Literacy for Math Workshop:

### Technology



#### District Professional Development Day Survey - September 20, 2019






