

#### To Superintendents:

After careful consideration, the Ministry of Education and Child Care has made the decision to amend the School Calendar Regulation to reduce the number of hours of instruction by five hours for the 2022/23 school year. This amendment is to accommodate the closure of schools on September 19, 2022, for the National Day of Mourning to mark the passing of Queen Elizabeth II. Please note that while your school board is required to amend its school calendar, the Ministry will be waiving the consultation requirements for the amendment. As such, boards will not be required to make the amendment publicly available prior to taking effect, and the amendment can be effective retroactively. Any questions regarding the School Calendar Regulation amendment can be directed to <u>EDUC.SchoolCalendars@gov.bc.ca</u>.

I know the September 19<sup>th</sup> school closure was unexpected and may have been disruptive for some students, families, and staff. Given that we are still at the beginning of the school year, I am confident that you and your teams will work collaboratively and creatively, as you always do, to ensure students meet their learning outcomes for this school year. I also know that you will continue to proactively monitor student needs to ensure that they are receiving the supports they need to keep progressing on their learning journey.

#### 3.1 Literacy

District Literacy Teacher Erin Jones presented the Framework for Enhancing Student Learning goal; students will meet or exceed literacy expectations for each grade level. Jones is supporting a district-wide grade two reading assessment realizing that the results have inconsistencies. Jones is following up with last year's grade twos in the spring of 2023. Jones will enable teachers in the district by focusing on the essential elements of literacy instruction and providing the appropriate intervention resources and supports for the higher-tiered learners.

#### 3.2 Numeracy

District Numeracy Teacher Kathy Conlin presented the Framework for Enhancing Student Learning goal; students will meet or exceed numeracy expectations for each grade level. Conlin references Jo Boaler's book, *Mathematical Mindset*, which is rooted in the neuroscience of mathematical thinking and encourages teachers to allow their students to think and collaborate rather than focus on the algorithms. From this mindset, Conlin collaborated with two other teachers and has developed 13 Days of Math. Conlin is working on a common mathematical assessment tool to have context for students' strengths and stretches. Conlin has created numeracy hubs for both teacher and parent resources.

#### 3.3 Social-Emotional Learning Teacher

District Social-Emotional Learning Teacher Kim Richards presented her role in the Framework for Enhancing Student Learning priority on human and social development. Richards has started a pilot project with three schools: FJ Mitchell Elementary, TM Roberts Elementary, and Steeples Elementary. Richards is working with the schools and

teachers to understand the connection between a student's emotional self and their nervous system responses; allowing teachers to validate each student's feelings and traumatic experiences and how the students present themselves in the classroom setting.

### LITERACY

September has been a busy month for Literacy in School District No. 5. Any K-3 teachers who were interested in learning more about the Heggerty Phonemic Awareness program were invited to attend a one-hour training session in which they not only learned about the program but left with a copy of the resource and a oneyear membership to the Heggerty online platform. Teachers were excited to learn about and, start using this resource which will support critical instruction in phonemic awareness for our youngest learners. So far about 50 teachers across the district have attended the training and received their resources.

Teachers from TM Roberts Elementary School joined Erin Jones, District Literacy Support Teacher to explore some essential components of early reading instruction. Teachers were introduced to some of the elements in the Science of Reading as well as research-based routines for developing essential word reading skills. They explored resources and participated in rich discussions and activities. Feedback from the session was very positive.

### NEWS FROM THE DRC

Thank you to Isabella Dicken Elementary School in Fernie for inviting the DRC Librarian, Maxine Malmberg, to their September staff meeting. She was able to showcase the DRC "browsing binder", new French Immersion resources, and the BC Digital Classroom.

### **NUMERACY**

This fall. grade teachers many enthusiastically implemented The First 13 Days of Math in their classrooms with great success. The resource was created to help teachers create positive culture classroom towards collaboration mathematical thinking. Collaboration between students, emphasis on justifying thinking, multiple answers strategies, play and inquiry with math concepts, and reflection of learning are all strengths of the resource. The resource can be found on our district portal under the numeracy icon.

#### GRADE 5/6 LEGO ROBOTICS ARCTIC RIDE AND TOWER CHALLENGE

Students in Ms. Bisson's grade 5/6 class from Rocky Mountain Elementary School explored the new Lego Essentials Robotics kits at the Fernie Design Lab. They designed and modified a coding program for a vehicle that could travel along a path using 90degree turns. Students broke the problem down into smaller parts (computational thinking decomposition) and learned how to sequence events in a block-based coding platform. They also took part in a tower design challenge to build the tallest and most aesthetic-looking tower using Lego. This challenged student's communication and problemsolving skills under pressure as they only had 5 minutes to complete the tower.





### NURSING PRACTICUM STUDENTS

School District No. 5 has partnered with the College of the Rockies to provide practicum experience to nursing students in their program.

First-year nursing students will deliver the BCCDC Handwashing Program (previously, "Do Bugs Need Drugs?") to kindergarten and/or K-1 split classes in all Cranbrook elementary schools.

Second-year nursing students will also be delivering the BCCDC Handwashing Program to grade 2 and/or 1/2 or 2/3 split classes at Amy Woodland, Kootenay Orchards, Pinewood, Steeples and T.M. Roberts elementary schools.

Third-year nursing students will be in a few of our schools, on Wednesdays and Thursdays each week from September 6th through to December 2nd. These nursing students will be at Jaffray Elementary Junior Secondary School, Kootenay Orchards Elementary, Laurie Middle School and Parkland Middle School. Page 38 of 41

### FRENCH IMMERSION GRANT

Our French teacher recruitment and retention project application for TTOC and Curriculum and Literacy Support time have been partially approved by the federal government.

We will be receiving funding to hire a 1.0 FTE itinerant French Immersion teacher in SD5. This funding will be available in both the 2022-2023 and 2023-2024 school years.

#### **HUMAN RESOURCES**

We are excited to welcome back many of the TTOCs and CUPE casuals from previous years. As well, we have been able to see many new faces that are joining us for their first year in a temporary, permanent, or casual role.

Our call-out department continues to be very busy assisting employees in getting activated for the upcoming school year.

We had a very successful teacher/TTOC orientation at Laurie Middle School that saw our largest crowd ever of just over 50 attendees. This day is always well received by our many new hires and includes presentations by several departments and a BCTF Boundaries Workshop in the afternoon presented by Shelly Balfour, CFTA co-chair. HR was also able to meet in person with our many school secretaries while we went over the importance of employee schedules, CUPE Casual and TTOC sign-in sheets at Parkland Middle School. We were also joined by many principals and vice principals across the district.
