1.6 Receiving of Delegations/Presentations

1.6.1 City of Fernie - Isabella Dickens Elementary

Mayor Mary Giuliano introduced the five City of Fernie Councilors in attendance. Mayor Giuliano and the Councilors appealed to the Board for replacement of Isabella Dickens School.

- Increase of population in Fernie
- School is too small for the number of students enrolled
- New school would increase the moral of students and staff

A hand out was distributed to the Board outlining statistics on increasing population in the City of Fernie. The Mayor expressed concern on how the school would be able to expand with the increased population.

Chairperson Lento read his report to the Mayor, Councilors, and the Board outlining his thoughts on partnering and building a multi-purpose facility to replace Isabella Dickens Elementary School.

Mayor Giuliano asked Chairperson Lento to present to the City of Fernie in the near future.

1.6.2 Budget Presentation – CFTA

Shelley Balfour and Christina Smith presented to the Board the following eight CFTA Budget recommendations.

- That the Board prepares and adopts a budget that adequately funds the schools in our district, especially in light of the massive curriculum changes in our Province.
- 2. That the Board provides schools with release time for school-based team meetings and IEP meetings.

- 3. That the Board hire a second School Psychologist on a permanent basis to further serve the needs of the students in School District 5.
- 4. That the Board commits to hiring Teachers Teaching on Call on continuing contracts especially for the remote communities.
- 5. That the Board negotiate a Letter of Understanding with the Union that Teachers Teaching on Call be paid on a bi-weekly schedule.
- 6. That the Board continues to share the cost with the BCTF of the Living with Balance Program.
- 7. That full-time Educational Assistant support be provided in all Kindergarten classrooms for the month of September when students are present.
- 8. That the Board fund an Early Learning teacher.

1.6.3 Jaffray PAC

Trustee Blumhagen shared a letter dated March 14, 2017 from Jeannette Edwards (PAC Chair) for Jaffray School expressing the need for increased funding from the District to help cover bussing costs for curricular and extra-curricular trips.
