Healthy School Mandate:

Parent request re; Clarification on the sale of "aspartame" products at the high school level when middle school level students are also in attendance? Fernie, Sparwood & Elkford Secondary, have students starting at grade 7, which is considered middle school and according to the guidelines, "Aspartame containing drinks are NOT allowed in middle schools". The rational given for the decision is "Removing artificially sweetened items from elementary and middle schools due to an increase in the number of

products containing these ingredients and a broadly expressed desire to minimize children's consumption of these products outside of parental supervision"

By official designation these Secondary's are actually high schools, therefore they can sell it according to the Guidelines, but the middle school aged students attending these schools now have access to it.

Discussion:

- Fresca, Coke Zero and possibly Diet Coke are currently made available in vending machines at Fernie Secondary
- Are they available in other schools?
- If so, how are they offered Re; concessions, vending machines etc.
- Was there a need to even sell these products?
