#### Highlights:

- Board letter to Prime Minister Harper re: Health Care Accord Canada is facing an important next step in our Medicare history. In 2014, the current health care accord (the deal that sets funding and health care service delivery agreements between the federal and provincial and territorial governments) expires and must be renegotiated. The federal government is ignoring the calls of the provinces and territories to work on a deal, and shockingly announced \$36 billion worth of health care cuts which will come into effect after the next federal election in 2015.

Secondary school trip, Spring break 2015. Destination to be determined - either Spain/Morocco or Turkey and Greece

## Discussion -

- There has been no official changes announced regarding SPCs
- Some but not all districts have experienced inadequacies in councils
- Resolution passed at the BC School Trustee AGM
   "That BCSTA request that the provincial government promptly consult with the
   relevant K-12 education stakeholders, including all employee groups, to update,
   replace, or rescind sections 8.1–8.3 of the School Act regarding School Planning
   Councils."
- These have changed considerably since their inception (removal of class size and composition etc.)
- Parents can feel overwhelmed and unsure of how to use the information they may receive
- Some councils have been reduced to simple parent signatures
- Some schools have chosen to bring the information to PAC due to lack of parent volunteers
