Dear Premier Clark and Minister Bernier:

RE: Government Firing of Vancouver School Board

The School District 5 (SD5), Southeast Kootenay District Parent Advisory Council (DPAC) would like to express our support of the request put forward by our Board in their November 8th, 2016 letter;

"...government implement restorative processes and procedures geared toward resolving conflict while giving equal representation from the education cogovernance partners (the MoE and BCSTA), with the intent of resolving issues between conflicting parties and respecting the democratic process."

It is our understanding that public education in BC is a co-governance model between elected Boards of Education and the Ministry of Education. Our parents were quite dismayed therefore, to learn that while "In other systems of shared responsibilities there are dispute mechanisms or appeal procedures in place to resolve conflict between parties", our provincial government chose to ignore such collaborative practices in favour of ignoring the democratic process that lead to the make-up of the VSB by simply firing the elected board of education of one of the largest districts in BC.

Having elected Trustees readily available to listen to and <u>represent</u> the students, parents, educators, partner groups and stakeholders throughout our district's communities couldn't be more valued in SD5, both as a tool for supporting students and as the <u>democratic voice of the constituents throughout our district.</u>



Our Trustees are elected, based in large part, on their willingness to advocate for the needs of our students and schools. If government can simply remove and replace Boards of Education who are representing their constituents'—which is the duty of <u>all</u> democratically elected officials, it is a sad day for British Columbians as it truly signals the undermining and erosion of the democratic process Canadian citizens hold dear as a <u>right</u>, and not a privilege

Therefore, SD5 DPAC further supports our Board's request...

"...that the MoE immediately call a by-election to restore democracy to the citizens of Vancouver."
