RE: \$1 Million Funding to "Specialized Education Schools"

The School District 5 (SD5), Southeast Kootenay District Parent Advisory Council (DPAC) would like to express our support of the request put forward by our Board in their October 11, 2016 letter;

Re: Government commitment to funding of an additional \$1 Million to Specialized Education Schools, with zero special education funding increase for public school districts.

It is our understanding that every child is entitled to an education that will allow them to develop to their fullest potential, if this is truly the case then all schools should receive additional funding for Special Education, not just the private sector. It is a real disappointment that the government would overlook this aspect of their decision and marginalize some of our most vulnerable children.

Dear Premier Clark and Ministers De Jong and Bernier:

RE: SD5 Needs Budget for 2016/2017

The School District 5 (SD5), Southeast Kootenay District Parent Advisory Council (DPAC) would like to not only express our support but we commend our Board of Education for their advocacy and policies that best support the students of our district as outlined in their October 14th, 2016 letter;

"...School District 5 (SD5) Southeast Kootenay Needs Budget for 2016/2017. As per Board policy, this budget is sent to your Ministry each year following our legislated, balanced budget."

However, we are completely dismayed that they must continue to take these necessary steps considering the potential return of proper investment in the future leaders of our province.

As your own Select Standing Committee on Finance and Government Services (SSCFGS) continues to identify and recommend the need for adequate and sustainable investment in education, clearly this is NOT a district issue.



As tax payers, parents no longer believe the "highest funding per-pupil" headline that usually appears at budget announcement time. They are all too aware that inflation and downloaded costs (e.g. hydro, medical, carbon offsets, mandatory programs, training, and resources etc.) can quickly equate into <u>less</u> in their child's schools and classrooms from year to year.

However, they are surprised to learn that while "K-12 education continues to be significantly underfunded and the SSCFGS recommendations unheeded" their elected officials choose to, "pay down debt faster than scheduled in last year's budget rather than invest that money in such an essential service as education" or "given the funding challenges faced by all 60 Boards of Education across the province, government is still focused on a \$100 million "Prosperity Fund" whose "lead priority" is debt retirement."

Even more surprising is "why government continues to choose investment in private over public education year over year as illustrated by the 61.7% funding increase independent schools have received since 2005, in comparison to the paltry 19.7% increase provided to public education during that same period."

With subsequent budget surplus and BCTF Supreme court announcements, parents can only wait anxiously in hopes there will be no further costs passed on to our Boards of Education and districts.

As for SD5 DPAC, we remain ever hopeful that "highest funding" will magically equate into political will that allows for adequate, sustainable, predictable funding that allows all students to reach their highest potential and our Board's Needs Budget policy to gather dust.
