9.1 PAC Gaming License Events; BCCPAC would like to alert and remind PACs that they are responsible for all gaming events that are carried out with a license obtained through them, e.g. school sport team using a PAC license for a raffle, PAC responsible for unsold tickets etc.

Be aware that it is of utmost importance that there be extreme compliance of guidelines - use of gaming funds and licences. Stay away from grey areas that might fall under scrutiny.

90 days to send in report on gaming event.

Pac minutes need to be kept for a minimum of 10 years - more info to come about archiving.

- 9.2 Proposed parent information event re; Liabilities of Raising Teens; the legal and personal liabilities that face parents raising teens e.g.
 - legal and insurance rules for parents of teens that are learning to drive as well as those who already passed their N
 - the owner is responsible to know that all drivers' licences are in order
 - coinsurance of a child's car makes you liable
 - use of alcohol voids insurance
 - 3 authorities that can remove a licence (parent, RCMP and issuing

authority). Read fine print!

- As a server, how responsible are you for the safety of an intoxicated person (rule of first drink served). You are responsible for the care and wellbeing of individual for all events following
- Legal age that parental notification (by police) is no longer required? After 18th birthday
 - If a child says they are scared of their parent MCFD must be called in (trumps RCMP)
 - If a teen texts or posts anything that is not allowed/accurate liability falls to parent

RCMP, insurance company, lawyer - panel of people to talk to parents of middle/secondary aged students about these issues. Something to consider for next school year.

So many minutes of instruction required - this is how calendar is created. Parent consultation is part of the process. Minutes of instruction are non-negotiable (legislated). Local language in collective agreement needs to mesh with this as well.

Dear Minister Philpott,

RE; Request for Additional Funding for Child and Youth Mental Health Services

At the April 12, 2017 meeting, the SD5 Southeast Kootenay District Parent Advisory Council (DPAC) was made aware of and discussed the following motion that was passed at our School Board's public meeting:

"That the Board write a letter to the Minister of Health (cc our local MP) asking for additional provincial funding for mental health."

Through this discussion, DPAC was also made aware of the *BC all-party Select Standing Committee on Children and Youth* (SSCCY) January 2016 report and we fully agree that all 23 recommendations contained in the report, require money if we truly want to see improved outcomes for our youth, not only in our province but across Canada.

While early intervention and co-ordinated, multi-agency integrated service delivery are considered the most promising solutions for improving child and youth mental health issues, without the necessary funding parents are left to deal with less than ideal outcomes for their children.

Provincial agencies, school boards and other much needed support service providers should never find funding as a barrier in aiding our most vulnerable citizens. However, particularly in rural communities, that is the reality for many parents when trying to access intervention and support.
